SINCE 1975, THE CENTER HAS RESPONDED TO MORE THAN 24,000 MARINE MAMMALS, INCLUDING SEA LIONS, ELEPHANT SEALS, HARBOR SEALS, FUR SEALS, SEA OTTERS, AND MORE.
